WHICH PERSONAL DATA OF YOURS IS PROCESSED?

- Your ID details (name, surname, Turkish ID number, passport number, etc.)
- Your contact details (address, phone number, e-mail address, etc)
- Your financial data (bank account details, credit card details, invoice details, etc)

TO WHOM MAY YOUR PERSONAL DATA BE TRANSFERRED AND FOR WHAT PURPOSES?

Your personal data collected by us may be transferred to our business partners, suppliers, shareholders, or statutorily authorized competent public bodies and private persons in line with personal data process conditions and purposes as set out in Articles 8 and 9 of the PDPL and this transfer is limited to the purposes set out in SARMAŞIK MAKİNA SANAYİ VE TİCARET A.Ş. Personal Data Process and Protection Policy that you can read at www.sarmasik.com.tr in order to allow our business departments to undertake required works to make available our Company's products and services to you, to carry out sales and marketing activities of our Company's products over our web site, to suggest such products and services of our Company to you as we will be customizing your choices depending on your needs, likes and usage habits, to ensure legal and commercial security of our Company and those persons who maintain a business relationship with our Company and to determine our Company's commercial and business strategies.

HOW DO WE COLLECT YOUR PERSONAL DATA?

Your personal data are collected by our Company in line with applicable laws and over different channels, including your registrations with this web site to use, and forms that you complete during that use and contracts made between you and our Company. Our goal here is to advance our business operations. Your personal data may be processed and transferred for the purposes described in this Privacy Policy in line with the objectives and conditions to process personal data as described in Articles 5 and 6 of the PDPL.

WHAT ARE YOUR RIGHTS AS A DATA SUBJECT?

We are under the obligation pursuant to the PDPL to give you information about whether any of your personal data has been registered by our Company, and if the answer is yes, to allow you to view, or, if necessary, delete or modify them.

You can send your requests in connection with your rights as data subjects to us by means of such methods described in SARMAŞIK MAKİNA SANAYİ VE TİCARET A.Ş. Personal Data Process and Protection Policy publicly posted at our web site. Our

Company shall finalize the application free of charge and as soon as possible depending on its nature but at the latest within thirty (30) days

In the case that the supply of the data that you ask from our Company in connection with your personal data costs a fee, we will be supplying this data against the payment of the fee set out in the tariff published by the Personal Data Protection Committee. Below are the rights of an individual whose personal data are processed pursuant to Article 11 of the PDPL:

- To inquire into whether his personal data are processed;
- To ask for information in case his personal data are processed;
- To inquire into the purpose underlying the process of his personal data, and whether or not such data are used in line with that purpose;
- To know about third parties to in Turkey or abroad to whom his personal data are transferred;
- Where his personal data are processed incompletely or wrongly, then to ask for its correction and to ask further that such corrective action shall be notified to third parties to whom his personal data are transferred;
- Even if his personal data are processed in accordance with the PDPL and other applicable laws, in the case that reasons for processing it are no longer applicable, to ask for the deletion or destruction of his personal data, and to ask further that such action shall be notified to third parties to whom his personal data are transferred;
- To object to any consequence that is detrimental to it and that arises from the analysis of processed data by means of solely automated systems;
- To claim damages in case you sustain a loss due to the unlawful process of your personal data.

HOW ARE YOUR PERSONAL DATA SECURED?

Your personal data that you permit us to collect are protected against losses, damages, and access by unauthorized persons, and we apply certain security measures for this purpose. Our security measures are in constant evolution in line with technological advancements.
